ICHA Vendor Space & Show Policies Terms and Conditions

Idaho Cutting Horse Association (ICHA) is the Lessor or show management. The Vendors/Exhibitors are the Lessee and agree to the following conditions:

Space Usage

The contracted space is solely for the use of the exhibitor listed on the application and contract. Subletting or assigning space is prohibited without prior written consent from show management. No oral modifications will alter this agreement. While efforts will be made to honor specific space requests, final assignments are at the discretion of show management. Booth occupancy is permitted only after full payment of fees and submission of a certificate of insurance.

Liabilities

Exhibitors are responsible for their leased space and must avoid damaging the premises. Driving nails, hooks, tacks, or screws into facility surfaces is prohibited. No advertisements or signs may be attached to facility walls without written approval from show management. Exhibitors are liable for any damages or losses incurred in their booth.

Exhibit Restrictions

Show management reserves the right to restrict or remove exhibits without refund if they are falsely entered or deemed inappropriate.

Insurance & Liability

Show management is not responsible for any exhibitor losses or damages. Exhibitors should secure valuable items overnight. Exhibitors agree to indemnify and hold show management harmless from any claims, damages, or losses arising from their activities. Vendors must provide a certificate of insurance.

Management Rights

Show management is not liable for any exhibitor expenses due to delays, interruptions, or cancellations of the show. Exhibitors are independent contractors and not employees, partners, or joint ventures of show management.

Aisles & Overhead Spaces

Aisles and overhead spaces are under the control of show management. No signs, decorations, or banners are allowed without written permission. Exhibits and personnel must stay within booth boundaries, and displays must not obstruct neighboring booths.

Licenses

Exhibitors are responsible for obtaining all necessary local, state, and federal licenses required by law. Idaho requires exhibitors to submit Form ST-24 before the show.

Fire Safety

Propane tanks and flammable materials are prohibited in the building.

Food Sales

Food and beverage sales are not permitted without written consent from show management.

Booth Setup & Merchandise

Vendors may set up their booths starting at 8:00 a.m. the day before the show begins. Booths must remain intact during active arena competition. After the show, merchandise should be removed as soon as the arena is cleared or by the following morning.

Exhibit Payment Terms

1. Exhibitor agrees to pay Lessor, at Lessor's principal place of business, one-half (1/2) of the total balance for the space upon execution of the lease as a deposit. The remaining balance must be paid prior to setting up in the exhibit space.
2. Exhibits or displays on ICHA show premises are permitted only upon signing of this contract by the Lessee and its acceptance by ICHA.
3. All merchandise must be confirmed with the assigned space(s) – NO EXCEPTIONS. Subject to the conditions herein, and for the term of this agreement, Lessor rents and leases to the Lessee the specified exhibit space. Lessee agrees to use the space exclusively for the stated purpose and to display only approved merchandise or services, and are subject to non compete with show sponsors. Any changes or additions to the listed merchandise must be approved by the Lessor. The Lessor reserves the right to approve or disapprove of exhibit materials without recourse.
